SCOPE AND CONTENT NOTE

The Disbursing Vouchers and Remittances series, which was administered primarily by secretaries E. G. Liebold and L. J. Thompson, consists of two subseries. The Remittances, Henry Ford Office subseries consists of one ledger containing remittance advices (i.e. documents accompanying payments listing the payee and the particular invoices being paid) for personal accounts of Henry Ford. Like the rest of the series, it covers a wide range of Henry Ford's non-Ford business activities.

The second subseries, the Disbursing Voucher subseries, is not a part of Accession 790. An inventory for the Disbursing Voucher subseries can be found in the finding aid for the Disbursing Vouchers subseries, 1912-1952, and Statements series, 1918-1950, Accession 286.
